



Included with our Microsoft license is Azure Information Protection (AIP). AIP is a Windows plugin that classifies, protects and encrypts documents before sending them in email or posting them on a website. AIP works like a plugin in your Word, Excel, PowerPoint or Outlook menus. A crucial part of any successful modern business involves the collection and storage of customer data. As stewards of the data we collect, every member of the campus community has a responsibility to ensure that our customer's data is adequately protected. In the context of Information Security, this means that we are ensuring that files are available when needed, remain unaltered and are not viewable by unauthorized individuals. Please note that protected data (as defined by the CSU Data Classification Survey) should never be shared outside our organization. We at the Information Security Office want to make sure that you have the tools you need to fulfill this responsibility, so we have begun campus-wide distribution of a new file protection software called Azure Information Protection (AIP). Why AIP? Unlike traditional file encryption software, AIP allows you to restrict access to files by email account. In addition, AIP ensures that your files are protected wherever they go, because unlike traditional file encryption solutions, AIP adds the protection to the file and not the storage location. How Do I Get it? Azure Information Protection is available through Software Center for systems running Office 2016 and older. Software Center is an application installed on all campus computers that allows you to download and install approved software. Click here for instructions regarding Software Center. While the former can classify documents, the latter helps to protect documents and emails across multiple devices including phones, tablets, and PCs. Every document or email is protected by encryption and various authentication policies. Each document is given a label that represents the kind of information that the document contains. These labels can be added either automatically through a set of rules or manually by the user. For example, administrators may automatically want to classify documents that contain credit card numbers. Every time this protected data is viewed, a check is done to see if the user viewing the IT administrators. This document-level security is very strong and works well even outside organizations because permissions remain with the file irrespective of where it is viewed, laptop, desktop, USB, etc. If someone without permission tries to view the file, they are blocked. Labels exist on portal azure com; you will use this portal to customize the settings related to labels and then you will add multiple labels to policy and then assign that policy to a group of users. Once the policy is assigned to a user, the user has to install an Azure Information Protection Viewer. It is a client that has to be installed on a user machine. Once that client is installed, the user will get a label bar in the application itself. The moment one has created a document, they can manually apply the label that they want while saving it.
